Caregiving in action

THROUGH THE EYES OF A CAREGIVER: Shea Ingrâm, COOK CHILDREN'S MUSIC THERAPIST, PROVES DAILY THAT MUSIC DOES OUR PATIENTS GOOD



For patients who are unable to create music on their own, such as newborns in our Neonatal Intensive Care Unit, Shea uses quieter instruments or songs to engage the patient in therapy.

hea Ingram has a cart full of musical instruments and toys that she takes with her to every patient she sees. As a board-certified music therapist at Cook Children's Medical Center for five years, each patient Shea treats is referred to her by a Child Life specialist, physician or nurse. With patients from every department within the medical center, Shea uses her experience to treat each patient uniquely.

A common misconception of her job is that she plays music to the patients. Instead, most of her patients play music to her. With music therapy, the music is a tool that gives children a safe outlet for expression. Even if they lack musical talent, patients play anyway, not worried about finding a rhythm or playing the chords correctly. Music gives patients control in an environment where they otherwise may have little, to no control. It gives patients something, other than their injury or illness, to focus on while in the medical center.

The goal for each patient varies. For some, it can be moving without fear of tubes getting tangled or pulled. And for others, it's getting them to sit up for 30 seconds at a time while playing a drum or expressing their feelings through music.

Patients can hand out instruments to Shea, their family members and nurses and then conduct their very own band. They can write a song, record it and take it home with them. No matter how they choose to participate, the kids think that they're having fun, but they are "working."

What makes Shea's job so worthwhile to her is seeing the parents' reaction to the emotional healing during their therapy. Parents tell her that music therapy brings a smile to their child's face that they haven't seen in a long time or that they were able to see a side of their child that may have gotten lost in his or her illness.

The music therapy program at Cook Children's is possible, in great part, to the generous support of the KidLinks Foundation. Shea's part-time schedule allows her to only see a portion of the patients that are referred to the music therapy program. Her hope is that the program will continue to grow, allowing every child an opportunity to heal through music therapy.



I just want to say a BIG thank you to Cook Children's. Recently, my 2-year-old son has been having some high blood sugar readings. We had been to the ER in Waco [we live about 45 miles from Waco] SEVERAL times and had a pretty traumatic experience for both my son and myself.

On August 10, we came to the ER at Cook Children's and I cannot say enough about how much different our experience was. Every single employee we came in contact with was BEYOND kind and understanding.



Fighting neuroblastoma

AS A PILOT FOR THE U.S. ARMY STATIONED IN AFGHANISTAN, JACK HUGHES COULDN'T WAIT TO GET HOME TO HIS WIFE, ASHTON, AND THEIR THREE YOUNG CHILDREN. LITTLE DID JACK KNOW THAT LESS THAN A MONTH AFTER HE GOT HOME, HE WOULD FACE THE MOST FRIGHTENING TIME OF HIS LIFE.

he enemy was stage 4, highrisk neuroblastoma and the attack was on 5-year-old David Hughes, the couple's son. Jack had gone from traveling the

world, to having it turned upside

"It was so shocking," Jack said. "I've read that for most kids with neuroblastoma, seems to come out of nowhere. It's found inadvertently it seems. David's been healthy. It had us all puzzled. It just hits you so quick. The person I am, I like to research and Google everything and find out as much as I can. It really throws you off your feet and in shock thinking about how much it's going to affect your life. Not just his life, but his parents' lives, his grandparents, his siblings... The entire family."

From early May to June 21, 2012, David complained of pain in his neck and hip, experienced high fevers and received nearly every scan and test imaginable. Then on June 21, David was diagnosed with cancer.

After the diagnosis, the Hughes family went for treatment near Belton, Texas, where Jack is stationed with the U.S. Army. At the nearby hospital in Temple, a physician told the family about Cook Children's experimental I-131 metaiodobenzylguanidine (MIBG) treatment that the medical center would soon be offering.

Jack knew about the program from his extensive research and through

neuroblastoma parent programs the family is involved with, and he and Ashton were on board. As it turned out, David was the first patient to receive the MIBG treatment at Cook Children's. Early signs are good for David, but it will take time for the family to know for sure if he is clear. They are happy they participated in the treatment and say they would tell other parents to do the same.

"The doctors at Cook Children's looked at everything and decided he was a good candidate for MIBG therapy. The timing has just been wonderful that this has opened up herê."

"We were going to do it," Ashton said. "If it hadn't opened up at Cook Children's, we would have gone elsewhere. We would do anything to help David. The doctors at Cook Children's looked at everything and decided he was a good candidate for MIBG therapy. The timing has just been wonderful

that this has opened up here."

Cook Children's opened its MIBG program in January of this year. MIBG is a targeted therapy that delivers radiation directly to cancer cells. MIBG uses an experimental radioactive isotope that seeks out neuroblastoma tumors, giving them more radiation than the normal

Cook Children's MIBG facility is the only one in Texas and in the Southwest, which means families don't have to travel as far away to receive this innovative treatment. It's also unique because it has a comfortable room right next door to the child's room for a parent or caregiver. This room has a window looking into the child's room, and they can interact using an intercom system. Parents can even stay connected to work or their family through the Wi-Fi provided in the

MIBG enters the body through the vein (in an IV). The IV infusion of MIBG takes about 90 minutes to two hours and is not painful. The child stays in the medical center for about five to seven days. Because MIBG is radioactive, it's handled very carefully. It also makes the child radioactive, which means he/she can't come out of the lead-lined room until the radiation has gone down to safe levels. This may take three to five days and in rare cases, longer.

It's a challenge to keep the child busy during this time. The MIBG treatment doesn't make them feel sick, so they should be their normal energetic selves. With the help of Child Life specialists, David was occupied with video games and TV, and by the last couple of days, he was entertaining everyone with pushups and returning back to his typical class-clown form.

The arrival of the MIBG treatment room is the culmination of four years of hard work by the Cook Children's staff. It's also the completion of a dream for many of the staff, including Meaghan Granger, M.D., director of the

Neuroblastoma program.

The cancer programs at Cook Children's have tremendous support from the community. It is only with the generosity of friends like Hyundai Hope on Wheels, Wipe Out Kids' Cancer, Tom Thumb Kindness for Kids and so many others that we are able to serve our cancer patients to the degree at which we do.

"We wouldn't even be talking about to make a difference this program if it wasn't for everyone who has helped," Dr. Granger said. "The hematology and oncology families at Cook Children's have formed a strong community of their own, fighting to make a difference in the lives of all of our cancer patients. These families are extremely engaged on a philanthropic level before, during and after treatment. They truly embrace the Cook Children's promise by hosting and supporting activities such as The Blast 5k, Wine for a Cause, Love Club, Caleb Larson Memorial Cowboyin'

for the Kids and various other events that benefit MIBG treatment. These families also played an important role in the design of the new cancer center by providing feedback and suggestions based on their experiences. All the hope they have for their own kids and wanting to help people, they know it trickles down to help one little patient like David."

parents and their newborn. Parents can be with their baby at all times, participating in every aspect of their



This designated area lets patient families get fresh air without having to leave the medical center. It's a place to gather outside the patient's room in a space where they can be a family together.

The Dillard family knows the

Another example of the Dillard family's support is "HeRO," a stateof-the-art heart rate observation technology that gives doctors and NICU nurses advance warning when a baby is at risk for infection. HeRO reassures parents, offering them peace of mind in one aspect of their child's care. And because HeRO works with existing monitors, there are no extra cords or devices to attach to a baby's tiny body making holding, feeding and changing the baby less cumbersome.

Employees can choose to round up the dollar amount in their paychecks with the "change" going to Cook Children's through Children's
